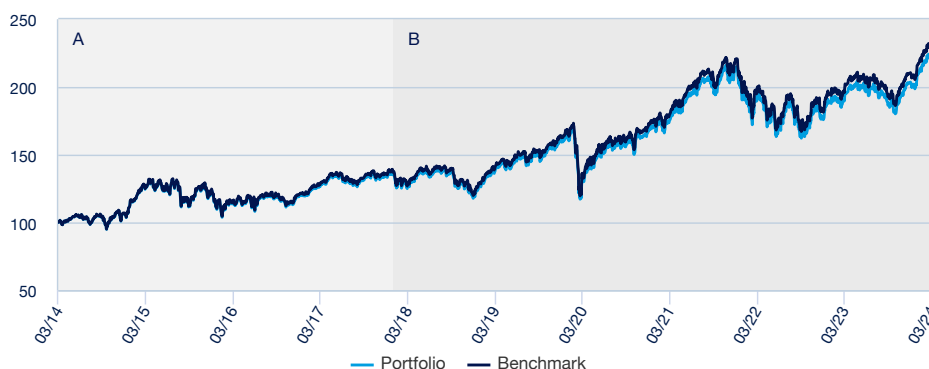

The MSCI Europe Growth strategy Index comprises around 250 stocks of growth companies and covering 16 European markets.

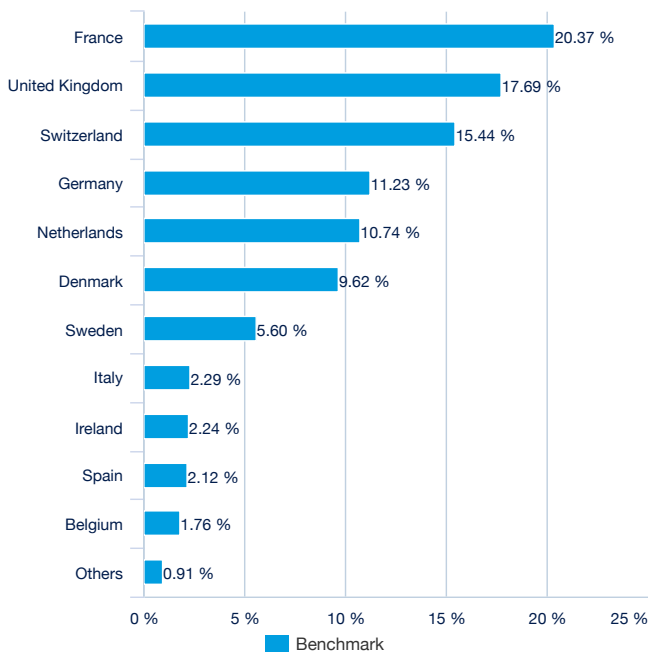

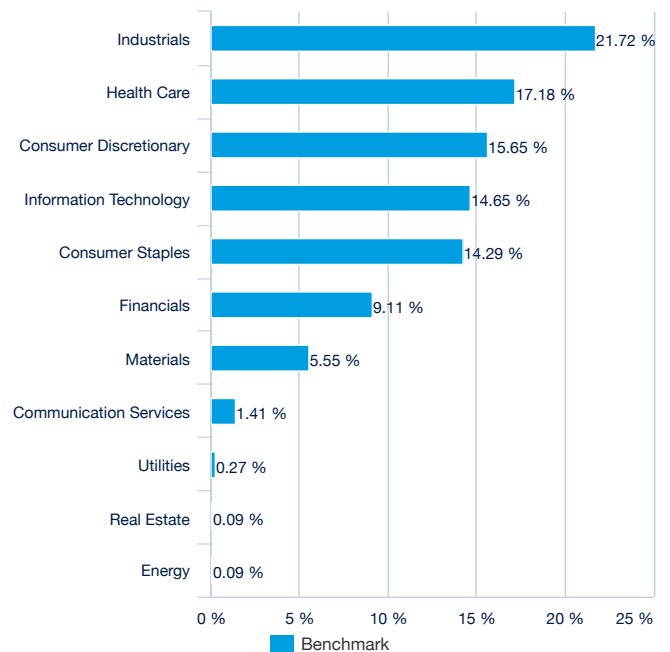
