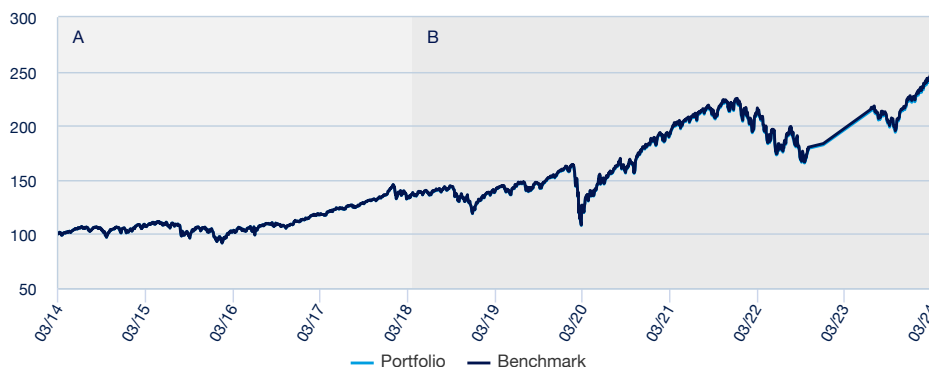

The MSCI World Index mirrors the performance of around 1700 stocks worldwide (31st March 2009).

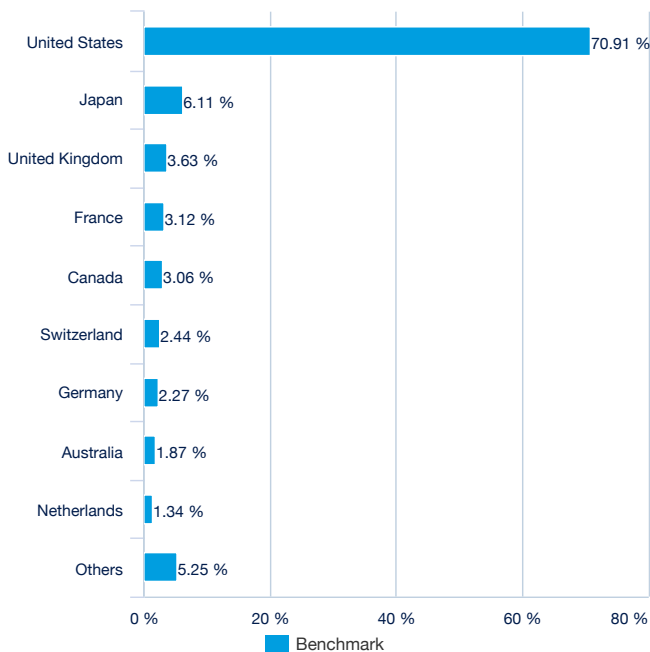

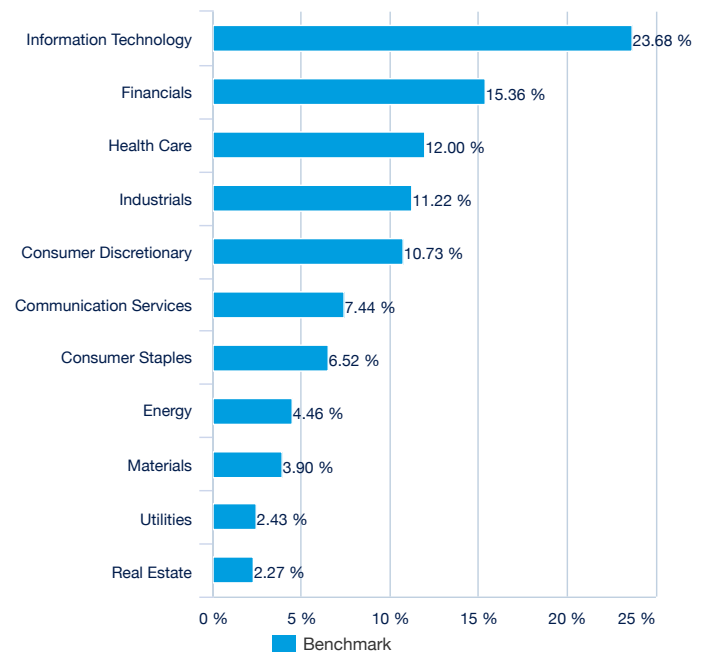
