Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of Bloomberg MSCI Euro Corporate 1-5 Year ESG Sustainability SRI Bond Index (the "Index"), and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The Sub-Fund aims to achieve a level of tracking error of the Sub Fund and its Index that will not normally exceed 1%.

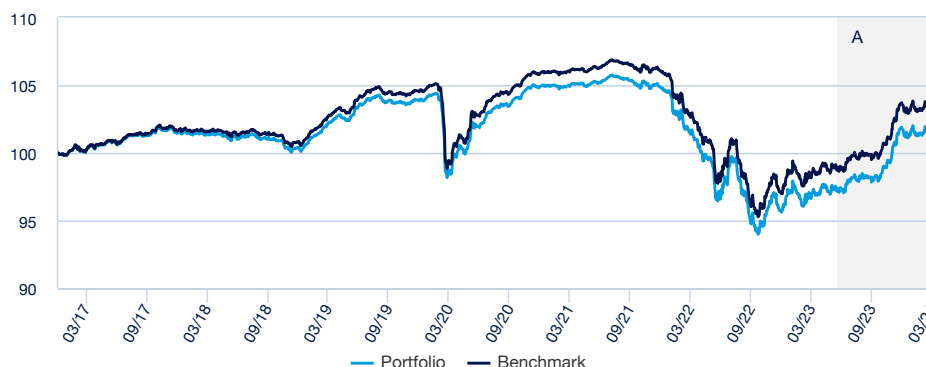

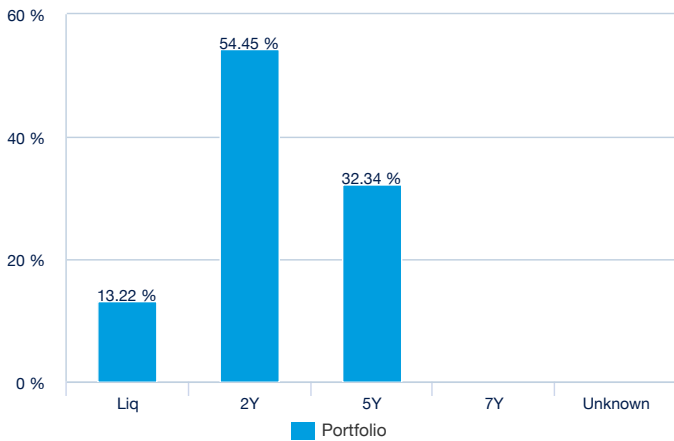

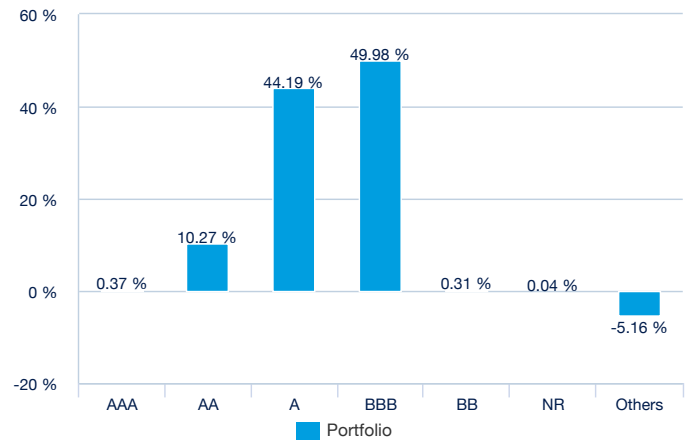

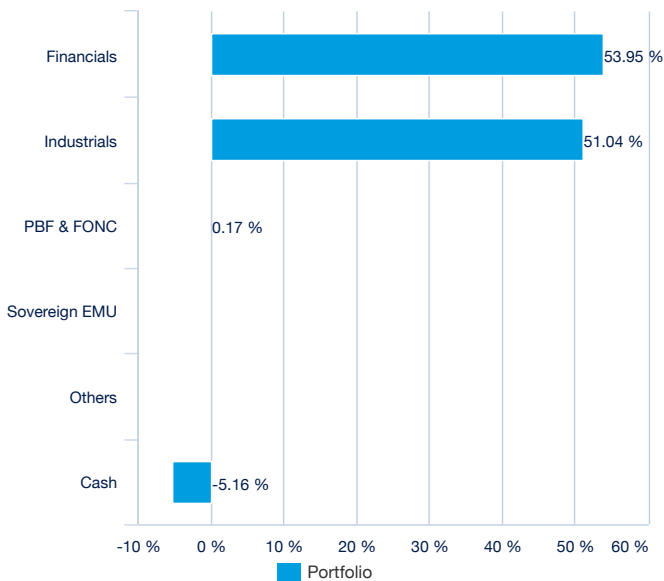
By maturity (Source: Amundi)



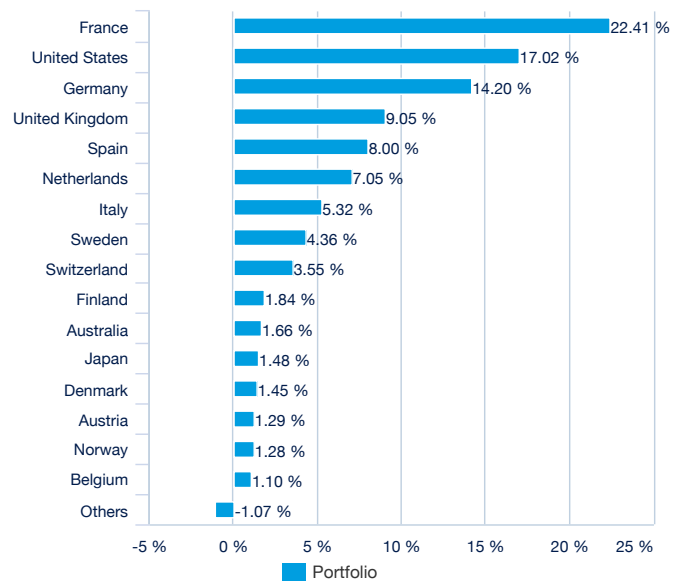
